

In order to enable transparent and nondiscriminatory new service user admission process, Board of Directors of SEE CAO approved:

Procedure for new service user admission

Article 1

SEE CAO is entitled to provide services of coordinated cross-border capacity allocation (further on: "Services") to all Transmission system operators (TSOs) that have joint border with other TSOs already using SEE CAO services.

Article 2

SEE CAO shall provide same Service under the same conditions to all service users either they are its shareholders or not.

Article 3

In order to apply for the Service provision, TSO shall submit the application (Appendix 1) indicating:

- Border(s) that will be offered on the auctions
- Year for which Service will be provided
- List of services
- Acceptance of the standard Auction rules (published at SEE CAO website)
- Request for delivery of the standard form of Agreement for services
- Request for delivery of the financial terms for service user including admission fee and service fee

Article 4

After receiving requested standard form of Agreement for services and financial terms including admission fee and service fee TSO willing to become a new service user should confirm acceptance of both in written form (Appendix 2).

Article 5

Service fee and admission fee are calculated on annual basis within the standard business planning procedures and do represent integral part of the annual Financial Plan.

Article 6

Admission of new service users is subject to approval by the Board of Directors in accordance with SEE CAO Articles of Association.
