In order to enable transparent and noniscriminatory new service user admision process, Board of Directors of SEE CAO approved:

Procedure for new service user admission

Article 1

SEE CAO is entitled to provide service of coordinated cross-border capacity allocation (further on: "Service") to all Transmission system operators (TSOs) that have joint border with other TSOs already using SEE CAO services.

Article 2

SEE CAO shall provide the Service under the same conditions to all TSOs either they are its shareholders or not.

Article 3

In order to apply for the Service provision, TSO shall submit the application (Appendix 1) indicating:

- Border(s) that will be offered on the auctions;
- Year for which Service will be provided;
- List of services;
- Acceptance of the standard form of the allocation rules;
- Acceptance of the standard form of Agreement for services¹;
- Acceptance of the financial terms including service fee;

Article 4

Service fee is calculated on annual basis within the standard business planning procedures and do represent integral part of the annual Financial Plan.

Article 5

Admission fee for Service provision to new Service user shall be determined based on costs of required adaptation of the Auction Tool.

¹ New Service user shall become a Contractual Party of the Agreement for Services between SEE CAO and participating TSOs regulating Cross Zonal Capacity Allocation on Bidding Zone borders containing detailed technical, financial and legal terms
